

On April 14, 2016 ANDRITZ AG was informed that certain subsidiaries of BlackRock Inc., Wilmington, Delaware, USA, as shown on the table below, have holdings in ANDRITZ AG, which is listed on the Vienna Stock Exchange. As of April 13, 2016, these subsidiaries held a total of 3.93% of ANDRITZ AG's share capital (104,000,000 shares).
